Easy Way to Apply

Please submit the completed form and enclose **other required documents**, which have been duly certified.

Individual

1. Copy of ID card or a copy of alien certificate / passport for foreign individual.
2. Copy of the front page of bankbook or bank statement with securities holder/securities owner's name and bank account number shown.

Thai Juristic Person

1. Copy of Affidavit issued by the Ministry of Commerce not more than 1 year prior to submission.
2. Copy of the ID card of authorized person.
3. Copy of the front page of bankbook or bank statement with securities holder/securities owner's name and bank account number shown.

Foreign Juristic Person

1. A copy of evidence proving the person is authorized to act on behalf of the juristic person and a sample of the person's signature authorized to sign, which was certified not more than 1 year prior to the date of submission by a Notary Public at the Embassy or Thai Consul in the country where the juristic person is located.
2. A copy of the passport of the person authorized.

Recommendations

1. In any case when the payment of dividend/interest to the shareholder's bank account cannot be processed, the registrar shall issue a dividend/interest cheque and shall have it delivered to the shareholder.
2. The registrar shall record the new details of your bank account within 15 days of the date your notification letter is received.
3. The shareholder shall verify the list of securities, which have been included in the e-Dividend program or shall download a copy of the notification letter onto www.tsd.co.th.

It is unnecessary to reapply if you have already applied for this service.
