# Documents to be submitted for printing documents for shareholders

#### Identification documents of shareholder

### ■ For Individual Persons

## Thai Nationality

- A copy of I.D. card or a copy of government official I.D. card together with a copy of house registration which the owner certifies true copy. (The card must not be expired.)

#### Other Nationalities

- A copy of alien I.D. card or a copy of passport which the owner certifies a true copy.

(The card must not be expired.)

#### ■ For Juristic Persons

## **Thai Nationality**

- 1. A copy of juristic person certificate issued by the Ministry of Commerce and not exceeding one year which the authorized directors certify true copy.
- 2. A copy of the I.D. card of authorized directors which the owner certifies a true copy.

#### Other Nationalities

- A copy of the juristic person registration certificate and a juristic person authorization certificate
  issued by an officer of juristic persons or by an authority of the country of origin with an original
  signature, name of an authorized person representing juristic persons, headquarters' location and
  authority of signatory
  - (A) With certification by notary public officer in the country from which the above documentation was made.
  - (B) With an authorization by the Thai Embassy or Consulate of Thailand in the country where the signatory certificate and notary public stamp were made.
- ◆ All documentation above must have been certified within one year from the time when submitted to the registrar.
  - 2. Copy of alien I.D. card or passport of an authority of juristic persons and which the owner certificates as a true copy.
